WRITTEN OBJECTION TO CLAIMS

TRICIA LOUISE ELLIOTT, being duly sworn deposes and says:

1. That I am the Defendant in the above referenced matter, and make this sworn Written Objection in response to the Summons and Complaint served upon me by the Plaintiff.
2. That I am residing at 302 Columbia Road 220, Emerson, Arkansas 71740. I am here because the Plaintiffs told myself and others that it was a "gift" for us to live in this residence, and to work for them.
3. That the allegation in the Complaint that the Plaintiff is registered in the State of Virginia is false. The Plaintiff does not have a registered business in the name of Halleluyah Scriptures, Inc in the state of Virginia. There is an entity registered in the State of New Jersey by that name. A copy of the said corporation documents are attached hereunto as "Exhibit A" and incorporated herein by reference.
4. Accordingly, the Plaintiff has failed to properly establish owner of the subject property and the right of possession.

5. That the Plaintiff signed an Agreement with me. That within this Agreement you will see we were told that we would receive \$350 a week for our works and the Plaintiffs would provide food, water, power, communications and homeschooling items for my children. In December our money was cut off and our food allocations for the month were also cut off. They never provided the Homeschooling items needed for my children. If we are a contract laborer, we never received a 1099 from them for the monies they paid, so they have violated the State and Federal Tax laws. The Plaintiffs also had my then 14 year old twins sign this contract violating tax laws and child labor laws. A copy of the said Contract is attached hereunto as "Exhibit B" and incorporated herein by reference. The reason I allowed my children to sign this agreement is because the Plaintiffs told me that it was for Matthew 18 (Bible Verse) if needed, that this was "not for man's court system" "we don't do that".

6. That this entire matter involves a contract dispute. It is not properly brought as an eviction proceeding. The Plaintiff actually served a Termination Letter upon the Defendant, which is what initiated the contract dispute. A copy of the said Termination Letter is attached hereunto as "Exhibit C" and incorporated herein by reference.

7. When the Termination Letter was delivered to me on January 19th, 2023 the people assaulted us, and the police were called. They tried to break into my living area while I was naked. I have a video of them trying to break into my housing. They also took the router so I could no longer communicate with the outside.

8. You will notice on the work agreement and the termination letter the signatures and names of the officers have different last names for 2 of the members, and you will also see on the "Exhibit A" that these names are different as so well. The contract we signed and Plaintiffs signed doesn't match the Termination Letter. Again, the Plaintiffs have not established that they even have the right to bring a proceeding against me.

9. The Plaintiffs have breached the contract as it states it is a one-year contract. All duties and beyond were completed and there is video of a phone call involving some of the Plaintiffs acknowledging the amount of orders and a less than .1% error rate on the items shipped. Again they also have breached this contract saying we are independent contractors, and not providing Tax documentation and putting underage children on a contract.

10. I have not left the property as I have no income and no place to go with 4 kids and animals. The Plaintiffs have left us no choice as they originally begged us to move to this location and live here. We took everything we had and moved here as we anticipated living here at least for one year


as per their agreement and verbal conversations that this would be a permean job for us. We have no working licensed vehicle. They have left us homeless, stranded and moneyless.

11. I do not have a current driver's license nor is my vehicle licensed as I have not had the money to take care of either of these items since they no longer paid us and in the termination letter. You will see that the Plaintiffs stated they would continue paying our fulfillment fees until the remaining weeks of the contract which they stated was 4 weeks. Our last payment received from the Plaintiff was January 16th, 2023. Therefore, they have left us stranded due to their continued violations of the Contract.

12. There is no way for me to pay the power bills as they have taken our income away and I am unable to find another job or location to move to without internet and the ability to drive as stated in Paragraph 11. Also there is no way the power bills for 1 1/2 months is \$2,759.00 when in January we had a phone conference and they stated that the power bill for December was around \$500. I also have a recording of this conversation. I will be happy to provide. The Plaintiff's are fraudulently attempting to make us pay their entire business power bill.

13. In fact, the only reason the Plaintiff's are so anxious to remove me is because I discovered their fraud and money laundering operation under the guise of giving away free Bibles.

WHEREFORE, Defendant requests that the Plaintiff's Request for a Writ of Possession be denied and that the Complaint be dismissed in its entirety, along with such other and further relief that the Court deems just and proper.

Our board of Trustees has met and, it is with a heavy heart, that I am tasked to inform you through the hand of brother Greg that we have determined to sell the property. We thank you for your service to Almighty YAH there.

Therefore, in concert with Article IV, Paragraph 2 (Term of Contract) of our executed FULFILLMENT SERVICES AGREEMENT dated 09/28/2022, this letter will serve as the required 30 day written notice to inform you that, as of February 16, 2023, your Independent Contractor services are no longer required and are hereby terminated. It is our intention to pay your fulfillment fees as you work out the remaining weeks of this contract which will end 4 weeks from the date of this notice or Thursday, February 16, 2023.


As we move forward in the days ahead, Greg will walk with you through any options that may become available for a seamless transition.
